| ○ 02/06 @16:27 | Hickson | Field Contact: <ul style="list-style-type: none">▪ Building Contractor locked vehicle keys in a vehicle that was parked on a job site in Oxbow. Wanted Deputies to check on the vehicle until a tow service arrived. |
| ○ 02/06 @18:40 | Hickson | Structure Fire: <ul style="list-style-type: none">▪ Residential fire in Hickson. Horace Fire & Rescue seemed the fire to be accidental. |
| ○ 02/09 @17:52 | Oxbow | Alarm: <ul style="list-style-type: none">▪ Residential alarm. The homeowner was on vacation and requested deputies to check the exterior of the home. The exterior of the home was found to be secured during the check. No signs of forced entry. |
| ○ 02/19 @00:04 | Oxbow | Alarm: <ul style="list-style-type: none">▪ Residential Alarm. Same residence as the previous alarm call. The homeowner was on vacation but requested deputies to cancel their response to the residence. |
| ○ 02/19 @2339 | Oxbow | Suicidal Person: <ul style="list-style-type: none">▪ Complainant stated their spouse was threatening to commit suicide with a firearm. Both the complainant and their spouse were intoxicated during the incident. Through the scope of the investigation, the spouse was arrested for terrorizing. |
| ○ 02/20 @19:15 | Hickson | Theft: <ul style="list-style-type: none">▪ The complainant stated they had a license plate stolen from their vehicle. The plate was entered as stolen; report was taken. |
| ○ 02/23 @13:59 | Oxbow | Abuse: <ul style="list-style-type: none">▪ Cass County Detective received a "cyber tip" that abuse was taking place within an Oxbow residence. This was the only information entered... |
| ○ 02/24 @12:32 | Hickson | Registered Offender: <ul style="list-style-type: none">▪ Check Completed. No issues or concerns. |
| ○ 02/27 @09:23 | Oxbow | Abuse: <ul style="list-style-type: none">▪ The complainant had questions about a child's coverage in a (Civil Protection Order) between 2 divorced parents that have a history of domestic violence. LE action was not taken due to the civil nature of the call. |
